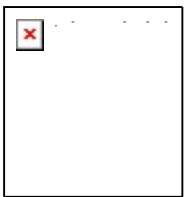

Lakeview Pantry, Chicago's largest and longest standing food pantry, has been a stable resource for our hungry neighbors for 50 years. We work to address the needs of food insecure individuals and families through food distribution, social services, and community mental health programs.

When the COVID pandemic hit Chicago, Lakeview Pantry responded immediately and without skipping a beat. All food programs were modified to limit person-to-person contact and protect the health and safety of our program participants, volunteers, and staff. Our licensed clinicians switched to a tele-health platform to continue providing case management and mental health counseling to individuals in a safe way. **At the peak of Lakeview Pantry's full emergency response, we saw more than 400% increase in demand across all programs.**

One of the key reasons Lakeview Pantry has been able to continue meeting the growing needs of our neighbors is through the support of community partners like Huntington National Bank. **In September 2020, Lakeview Pantry received an impact grant from Huntington National Bank to have an impact on food access in Chicago.** The funds granted to Lakeview Pantry helped to provide 80,000 meals for hungry individuals and families across Chicagoland.

Lakeview Pantry is incredibly grateful to have Huntington National Bank on our team in the fight against hunger in Chicago. We look forward to continuing our partnership in the future as we continue to provide "food for today, hope for tomorrow".
