Summary: Staff of the Federal Reserve Board, the Office of the Comptroller of the Currency, and the Federal Deposit Insurance Corporation met with Hal Johnson and other representatives of the Regional Bank Treasurers Group to discuss the proposed Net Stable Funding Ratio rule, which would implement the Basel III liquidity standards in the United States. Meeting participants discussed the scope of application of the proposed rule, timing for implementation of various parts of the proposed rule, and inconsistency with the Liquidity Coverage Ratio rule in the treatment of certain liabilities. In addition, representatives discussed the proposed rule's requirement for a remediation plan in case of a liquidity shortfall and the treatment of credit facilities.
